Old Business

Charter School update (691 St. Nicholas Avenue)

We were unable to communicate with the school prior to this meeting. Derek Johnson will make it a priority to reach out to the School so that they can meet with us. Discussion about having a preliminary meeting with interested neighbors to create an agenda and then invite them to a general block association meeting using the agenda we come up with.

Security cameras

We have been allocated \$8500 funding for the security cameras from The Citizen's Commission. The money will be distributed to us by the end of the year.

New Business

Film crews on block

There is a concern that we don't have sufficient advanced notice for when they will be coming to the block. Derek Johnson suggests that the city be requested to contact us when a permit is applied for.

One concern is that the companies leave trash in residents' trash bins.

The production companies donate money to the block when asked. Amounts have ranged from \$200 to \$500 to even \$1000 upon occasion. So the block is compensated for the temporary disruption.

We can ask them how much parking they need to make sure they're not taking more parking than they need.
