Discussion:

From 2022, under budget. Fewer parties, block beautification, and events. On budget for rat remediation. Spent more than usual on digital communication, etc. (Wix, Zoom, etc.)

Money in: \$6000 from film studio, dues, and donations.

"Sponsorship" = donations.

Chelsea: Has anyone offered to sponsor anything, such as Mutt Mitts? Liz: Not yet.

Liz: What adjustments to the budget should we make? Derek, who had lots of movie rentals in his home, has moved away, and so we should expect less revenue in the future.

Concerns were raised that because the Mutt Mitts get stolen in bulk by dog walkers, we should not include them in the 2023 budget. There was general agreement, and it was proposed to evaluate any changes to this line item in one year.

-Beautification (\$150)

Chelsea John proposed to keep the budget as is. Liz Wolfe seconded. Might be Spring or Fall Clean-up events.

-Rat Remediation

Concerns were raised that Suburban Pest is still coming regularly since we are paying monthly fees. Billy Geddes indicated that they usually contact him and are presumably filling them. Suggested that we contact them for an update now and again. Questions were raised about bringing cats back on the block and whether we could set the traps ourselves. It was determined that cats are not feasible and we could consider in the future to fill our own traps.
